Since 1992, Tejano Center for Community Concerns (Tejano Center) has served as an agent for change. Made bold by its mission to empower and transform lives by creating a network of support and opportunity among neighborhood residents and communities in need, Tejano Center provides a comprehensive array of social, health, educational, economic, and housing services.

#### AFFORDABLE HOUSING

Tejano Center is a Community Housing Development Organization (CHDO) and HUD Approved Housing Counseling Agency. The affordable housing program provides single family and multifamily housing development as well as housing counseling services and Homebuyer Education. Through these efforts, Tejano Center has been able to prepare over 2,000 new home owners and 3,300 mortgage ready homebuyers. The affordable housing program also provides disaster relief and recovery to eligible homeowners affected by severe weather events.



#### **BAYLOR COLLEGE OF MEDICINE TEEN HEALTH CLINIC**



Tejano Center partners with Baylor College of Medicine Teen Health Clinic to offer free or low-cost comprehensive health care and education to students ages 13 and older enrolled at Raul Yzaguirre Schools for Success, as well as any area teens in that age group. The clinic is a collaborative effort of Baylor College of Medicine, Community Health Choice, the Simmons Foundation and Tejano Center for Community Concerns. Services provided by the clinic, with parental consent, include screening and treatment for sexually transmitted infections and HIV, health risk reduction education, prenatal care, sports physicals, wellness exams, nutritional information and education, counseling and case management social work.

## CHILD PLACING AGENCY (FOSTER HOME CERTIFICATION)

Tejano Center for Community Concerns (TCCC) works hard to serve the children in our community that have experienced neglect and/or abuse. We do this by securing a safe and loving foster home that can meet their basic needs. Our foster parents open their hearts and their homes to provide children with healthy living conditions and positive relationships, which enhance their competencies in and out of school.



#### **EARLY HEADSTART EARLY CHILDHOOD EDUCATION**



Head Start ensures partnerships between families, staff, communities and schools. Parental involvement is integral to the success of any Head Start program. The RYSS Head Start Early Childhood Academy is designed to foster the parent's role as the principal influence on the child's development and as the child's primary educator, nurturer, and advocate. The programs work closely with parents to develop and utilize parents' individual strengths in order to meet personal and family goals. Parents are encouraged to become involved in policy and program decisions that respond to their needs and interests.

#### **FAMILY AND COMMUNITY ENGAGEMENT**

Tejano Center's Family and Community Engagement (FACE) program coordinates the many interactions and collaborations between the center with the larger community, including parents, business partners, civic and service organizations, governmental agencies, and other individuals who share an interest in our mission.

#### **NOVA ACADEMY FOR ADULT EDUCATION**



In collaboration with the Houston Community College, Tejano Center is able to provide Adult Basic Education and English as a Second Language classes to primarily Spanish speaking monolingual adults. The classes target parents and other adult family members of RYSS students, but is open to all residents of East End neighborhoods. The classes facilitate improved opportunities in the work force, advanced educational services including GED, as well as, skilled and semi-skilled job training entry level positions.

#### **NUEVA VIDA SENIOR CITIZEN HOUSING**

Nueva Vida is a supportive housing project targeting the very low income elderly, age 62 and over. It consists of 66 one bedroom apartments that provide independent living opportunities to senior citizens. Each apartment is self-sufficient with a small kitchen, dining area, appliances, a living area, a bedroom, and a bathroom. A community room is available to residents on site. Facilities include a dining area that doubles up as a classroom, a computer station, a television sitting area, and a stationary exercise bicycle. Nueva Vida also incorporates comprehensive care and support services to residents.



#### **GRADcafé by Project GRAD**



Project GRAD reaches deeply into the communities we serve in order to achieve our mission, partnering with trusted community organizations, high schools and charter schools, and community colleges and universities. Our programs provide a continuum of services during students' high school years, as they transition to college, and while they are pursuing a workforce certificate, associate's degree, or bachelor's degree. Since 1994, GRAD has worked in economically disadvantaged communities to become Houston's premier organization supporting students on the journey to and through college. GRAD has a deep knowledge of the challenges facing students and families.

#### **SUNRISE LOFTS**

In the state of Texas, when youth age out of Foster Care, there are very few housing options; especially, any that provide workforce training, graduation diploma obtainment options, and life skills training for independent living. Unfortunately, without options, many of these become homeless youth and live on the streets. When Sunrise Lofts opens in 2023, it will have 89 apartments where youth aging out of foster can live and receive all the wraparound services essential to develop independence and resilience.

## RAUL YZAGUIRRE SCHOOLS FOR SUCCESS (RYSS)

Founded in 1996, Raul Yzaguirre Schools for Success (RYSS) was one of the first open-enrollment charter schools approved by the Texas State Board of Education. By establishing RYSS, the Tejano Center for Community Concerns worked to provide a college preparatory educational experience for children of the center's surrounding neighborhoods in southeast Houston. Today, RYSS continues its commitment to the success of every student, regardless of his/her academic or economic background, by offering a superior college preparatory experience, with the goal of having every student enter and graduate from a four-year university.



# VICTIMS OF CRIME OUTREACH AND SUPPORT (VOCA)



Victims of Crime Outreach and Support Program (VOCA) targets victims of human trafficking and domestic violence. VOCA staff bring support and assistance directly to the victims in hopes of a speedy recovery. VOCA also works closely with community partners in order to better our communities. Partners include Star of Hope, YMCA International, Harris County Juvenile and Adult Probation. Some of the services include counseling, mentoring, shelter and aid through the legal system. Also, helping these individuals obtain government assistance until they are able to stand on their own.
